





# **Laws and Regulations**

Laws are currently in place that support making naloxone more readily available. For example, <u>California Civil Code Section 1714.22</u> (<u>Statutes of 2013, Chapter 707, Sec. 1) (PDF)</u> eliminates civil and criminal liability for: 1) licensed health care providers that prescribe naloxone and issue standing orders for the distribution of naloxone, and 2) individuals that administer naloxone to someone suspected of experiencing an overdose after receiving it along with required training. This law took effect on January 1, 2014.

SHASTA COUNTY, Calif. — The growth of fentanyl use, overdoses, and deaths have been well-documented, nationally and locally. Today, Shasta County Supervisors heard more about it and pledged to do something about it.

Adult Services Program Manager Katie Cassidy consolidated information from various sources in a presentation to the board: Since 2019, there have been 95 deaths; 402 overdoses in Shasta County. She says several highways meet in and around Redding and that could contribute to a high rate of opioid use and abuse.

"The I-5 corridor: a huge trafficking zone where it intersects with multiple highways which, we think, also influences that," said Katie. "The fentanyl deaths really are concentrated more along the I-5 corridor, is another pattern that was brought to light with this information. Whereas when we can take a comparison with the meth data, it was more spread out across the community."

The number of cases is showing a sharp rise with the primary affected age group from 25-44 years old.








# **ACE Score vs Smoking**




# ACE Score vs Alcohol Use by age 14


#### What is Naloxone?

Naloxone is a medication that works almost immediately to reverse opiate overdose. Naloxone is currently a prescription drug, but is not a controlled substance. It has few known adverse effects, no potential for abuse, and can be rapidly administered through intramuscular injection or nasal spray. While most professional first responders and emergency departments are equipped with naloxone, emergency service providers may not arrive in time to revive overdose victims. Trained and equipped bystanders such as friends, family and other non-health care providers (lay people) and drug users themselves can effectively respond and reverse an opioid overdose. Given the success of bystander naloxone programs, the CDC and the World Health Organization have recommended expanding the availability of naloxone to lay people.

One person is dead and a dozen others were rushed to the hospital after an apparent mass fentanyl overdose in Chico, California, on Saturday morning.

Four of those taken to the hospital are in critical condition, according to authorities. Police called the 13 people "friends and acquaintances," but did not provide exact relationships to the homeowner. The victims ranged in age from 19 to "about 30," police said.

Police did not provide many details of the person who died, but said he was an adult male who died on the scene.

Two police officers, the first to appear on the scene, were also taken to the hospital after reporting symptoms. They were treated and released, police said.



# U.S. fentanyl bust in Lego box points to Mexican cartels, DEA says

Oct 5 (Reuters) - U.S. authorities seized 15,000 rainbow-colored fentanyl pills hidden in a Lego toy box destined for distribution in New York City, the city's largest such seizure to date according to the U.S. Drug Enforcement Administration (DEA).

A grain of salt weighs about 60 micrograms. Fentanyl the size of 3 grains of salt can be lethal.



#### **Recommendation:**

Approve a letter of support in favor of Sierra Nevada Cheese Company's grant application for their anaerobic digestion project.

#### **Rationale for Recommendation:**

Requested by Mayor Hansen.

#### **Background:**

Sierra Nevada Cheese Company is applying for a grant from the California Energy Commission (energy.ca.gov) to install an Anaerobic Digestion (AD) facility that processes wastewater from cheese production. Anaerobic digestion is a process where bacteria consume waste and generate methane as a byproduct (e.g., biogas). Biogas produced by the AD facility will fuel an electric generator and provide clean, renewable electricity to the cheese factory. The AD facility will also process the wastewater into a high-quality water supply to irrigate orchards and agricultural land.

#### **Discussion & Analysis:**

The result will be a dramatic decrease in greenhouse gas emissions from the facility, improved water quality for the region, and growing economic and environmental sustainability for the company. To minimize environmental impact and integrate it into existing operations, the AD facility will be built in what is now an open-air lagoon. Benefits of the project include: A reduction of electrical and natural gas costs, eliminate waste disposal costs, ease load demand on the power grid, create new jobs, cut facility air emissions, and improve water quality.

Subject: Glenn Groundwater Authority - Prop 218 Study

#### **Recommendation:**

Discuss the Glenn Groundwater Authority's upcoming Proposition 218 Study and approve paying the GGA assessment on City of Willows parcels.

#### **Rationale for Recommendation:**

The GGA seeks direction from the City of Willows as to whether it wishes to continue to directly fund the agency on behalf of property owners (as it has done since 2019) or opt for some other approach. This is a continuation of the discussion from the February 13, 2024, City Council meeting.

#### **Background:**

In 2014, the Sustainable Groundwater Management Act was passed and signed into California State Law which set into motion a change in the way groundwater is managed throughout California. In 2017, the Glenn Groundwater Authority was formed, which is currently comprised of ten member agencies, including the City of Willows. The first two years of operations were funded by member agency contributions.

In 2019, the Glenn Groundwater Authority approved a property-related fee to fund the operations of the agency. The maximum fee was set at \$1.93 per acre. The first year, the fee was set at \$1.61 per acre and has since been set at \$1.50 per acre. The City of Willows adopted Resolution 16-2019 memorializing the City's intention to directly fund the Glenn Groundwater Authority for the acreage within the City limits of Willows and the property owned by the City of Willows. The City of Orland passed a similar Resolution with the same commitment.

#### **Discussion & Analysis:**

While the Glenn Groundwater Authority is currently updating its fees, the City has paid approximately \$2600 per year over the past four years (with very slight annual variations).

Currently, via a Proposition 218 Study, the GGA is considering property-related fees based on assigned user classifications for each parcel to distinguish between different types of water users. As a result of the proposed Proposition 218 Study, the GGA anticipates that the rates will increase to between \$2.40 and \$5.50 per acre. The total new assessment cost to the City of Willows would range between \$4,159 and \$9,531 per year.

As demonstrated by the City's past support, the Glenn Groundwater Authority is seeking the continued assistance of the City of Willows to directly fund the Glenn Groundwater Authority on behalf of the property owners within the City's jurisdiction.

#### **Fiscal Impact:**

Depending on the results of the Proposition 218 study, and if the City wishes to continue its commitment to directly fund the GGA on behalf of property owners, the City would incur a cost of up to approximately \$10,000 per year.
