Subject: Municipal Code 18.141.060 - Color Scheme Modification

Recommendation:

Review modifications to the City of Willows Municipal Code 18.141.060 and approve a recommendation for a new color scheme.

Rationale for Recommendation:

The current language is highly subjective, the objective of the modification would be to provide a specific range of colors for selection, with certain exceptions.

Background:

At the January 24, 2024 Planning Commission meeting, staff was given direction to make color selection language in Municipal Code Section 18.141.060 less ambiguous.

Discussion & Analysis:

Municipal Code 18.141.060 (4) currently reads:

"Materials and Colors Used. Soft and muted colors in the earthtone and woodtone range and natural materials are preferred and generally should predominate. Other colors and materials may be accepted if the applicant can demonstrate that they are appropriate to the style, are appropriate accent colors, and are harmonious with the site or compatible with the character of the neighborhood.

(a) Earthtone and woodtone colors are considered to be various shades of reddishbrown, brown, tan, ocher, umber, gold, sand and green. Color schemes for new residential construction are incorporated into the single-family design guidelines."
