Dear Willows' Community Members,

As the Fire Chief, it is my pleasure to present the 2023 Annual Report on behalf of the Willows Fire Department. This past year resulted in great progress for the Department, the Rural District and the Volunteer Department. Major strides were made in staffing, volunteer participation, training, and increased and improved equipment.

The Willows Fire Department authored 15 successful grant packages totaling over two million dollars of grant funds received in 2022 alone. These grant monies funded greatly needed capital equipment replacements improving long overdue firefighter safety and emergency response capabilities.

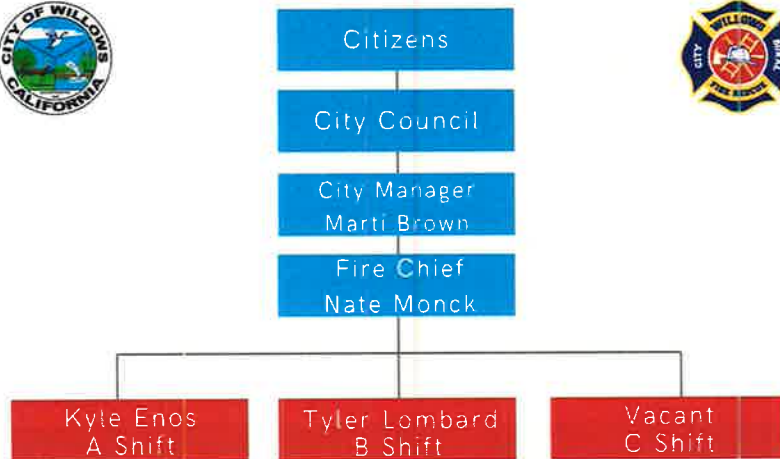
The Volunteer Fire Department added nine Volunteer Firefighters to their ranks and reinstated fire prevention week at our local schools. Willows Firefighters spent over 2000 hours training and preparing to serve Willows residents, business and property owners, and visitors.

In 2023, the Willows Fire Department, Rural District and the Volunteer Department will continue to provide effective, responsible, and professional fire protection and emergency medical services with the resources allocated. There is still much work to be done this next year, including increased training, expanding services, mitigating risk, improving internal processes, recruitment and retention of volunteer and career staff, and continuing to upgrade Department equipment and apparatus.

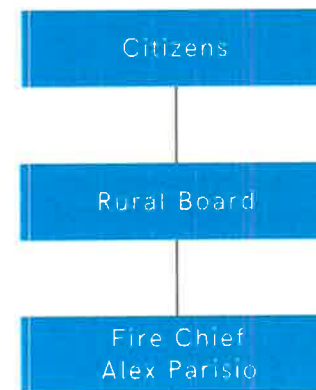

City of Willows Fire Department

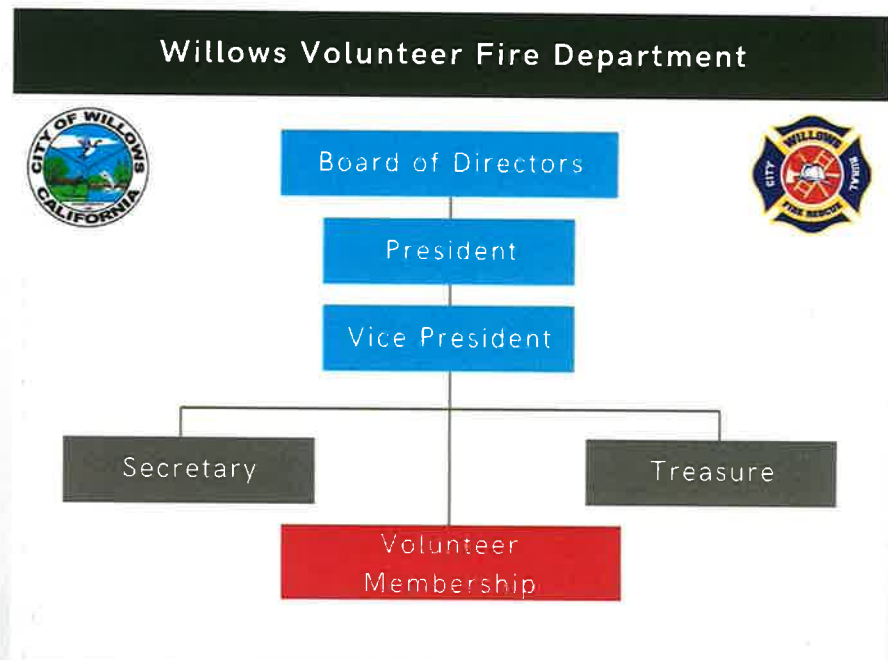


Willows Rural Fire Protection District

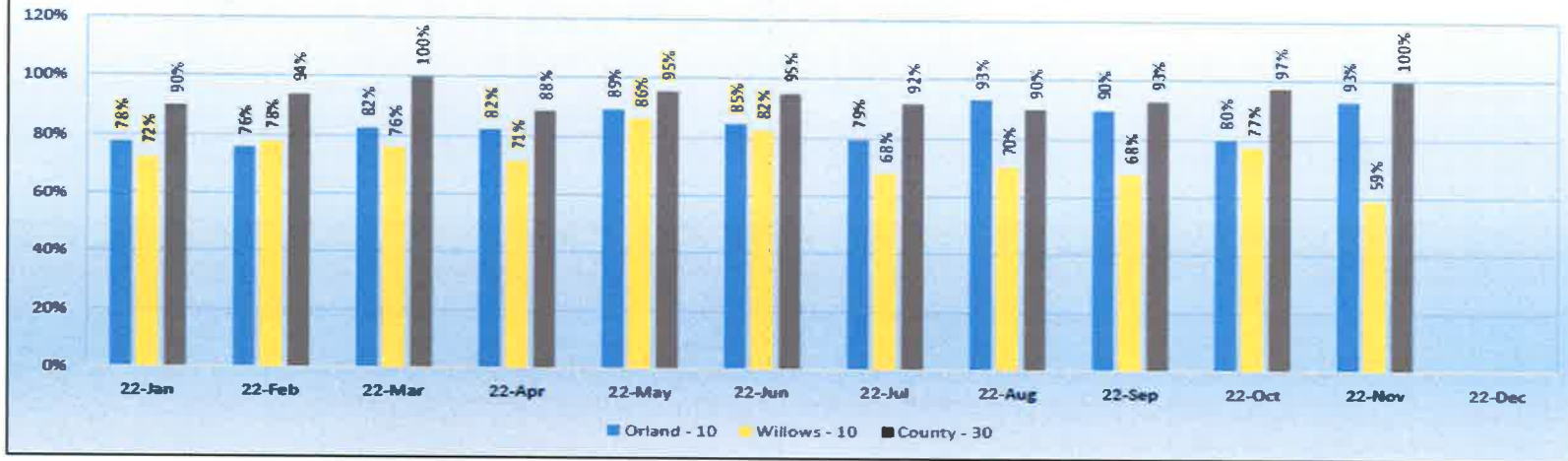

2022 Accomplishments & Highlights

- Responded to **1,183** calls for service.
- Spent over **2000** hours training for emergencies.
- Recruited and trained **9** new volunteer firefighters.
- Submitted **15** successful grant packages securing more than **2 million** in funding.
- Replaced SCBAs, Thermal imaging camera, hose, nozzles, mobile and portable radios and structure gear.

2022 Accomplishments & Highlights

- Replacement of unsafe and unreliable mobile and portable radios with grant funding.
- Replacement of unreliable pagers with grant funding.
- Replacement of E-12 with Grant Funding.
- Promotion of Fire Engineers to rank of Captain.
- Implemented streamlined training program.
- Replaced non-compliant hose and nozzles.
- Obtained used Type 3 Engine for City at no cost.
- Hosted many joint agency trainings with mutual aide partners.

2022 Accomplishments & Highlights

- **Implemented Fire Recovery Program with over \$25K recovered between May and December 2022.**
- **Performed 3 major emergency summary abatements.**
- **Re-Adopted Fire Codes, loosening fire department restrictions for new development.**
- **Completed mandated annual maintenance such as pump testing, hose testing, SCBA flow testing, and ladder testing.**
- **Completed 2022 weed abatement.**

Engine 3 - Type 1 Fire Engine

- Placed into Service: 2020
- Life Expectancy: 30 Years (15F/15R)
 - Reserve Status: 2035
 - **Replace:** 2050
- Estimated Replacement Cost in 2050 = \$1.4M
- Condition = Like New



City of Willows Fire Apparatus

Engine 2- Reserve Type 1 Engine

- Placed into Service: 1994
- Life Expectancy: 30 Years
- Replacement Date: 2024
- Condition = Poor
- Estimated Cost of Replacement = \$950,000
- **Should be ordered ASAP, current build time is up to 36 months.**

Truck 4 - 77' Quint (Ladder Truck/Pumper)

- Placed into Service: 2004
- Life Expectancy: 25 Years
- Replacement Date: 2029
- Condition: Good
- Estimated Cost of Replacement in 2029: \$2M

- Placed into Service: 2002
- Life Expectancy: 20 Years (10F/10R)
 - Placed in Reserve: 2018

- **Replacement funded by Cal Fire Grant, anticipated delivery May of 2023.**

 - Reserve Status: **Not in Reserve**
 - Replacement Date: 2026
- Condition: Poor
- Estimated Cost of Replacement: \$250k
- **Replacement funded by USDA Grant, anticipated delivery January of 2024.**



Willows Rural Fire District Apparatus

- **OES 370 - Type 1 Fire Engine**
 - Placed into Service: 2012 (E-12 is a 2006)
 - Life Expectancy: N/A
 - Maintained and Owned by Office of Emergency Services.
 - Condition: Fair
 - Estimated Cost of Replacement: None
 - OES trades the use of the engine for staffing during states of emergency.
- **Removed from service March 2022.**



Willows Rural Fire District Apparatus

WT - 15 – Tactical Water Tender

- Placed in Service: 2016 (E-12 is a 2006)
- Life Expectancy: 30 Years (30F)
 - Reserve Status: **Not in Reserve**
 - Replacement Date: 2046
 - Condition: Like New
- Estimated Cost of Replacement: \$550k



Willows Rural Fire District Apparatus

Air Cascade Trailer

- Placed into Service: 2007 (E-12 is a 2006)
- Life Expectancy: 40 Years (40F)
 - Reserve Status: **Not in Reserve**
 - Replacement Date: 2047
 - Condition: Good
- Estimated Cost of Replacement: \$150k



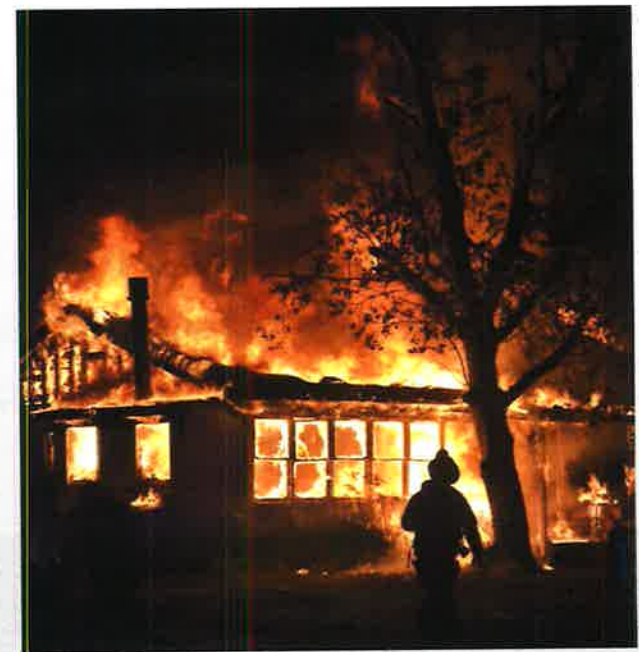
2023 Willows Fire Department Priorities



- Mitigation of emergencies
- Training to mitigate emergencies
- Recruitment and growth of the Willows Volunteer Fire Department
- Transition from a reactive organization to a proactive organization
- Securing outside funding sources (e.g., grants)
- Replacement of unsafe and outdated safety equipment
- Increase community involvement and participation

2023 Willows Fire Projects

- **Transition to Centralized Dispatch.**
- **Continue to track and manage grant related activities.**
- **Explore long term sustainable solutions for future Fire Department funding needs (e.g., capital improvement fund).**
- **Source funding for additional Advanced Life Support services ensuring the citizens of Willows have prompt access to emergency medical care.**
