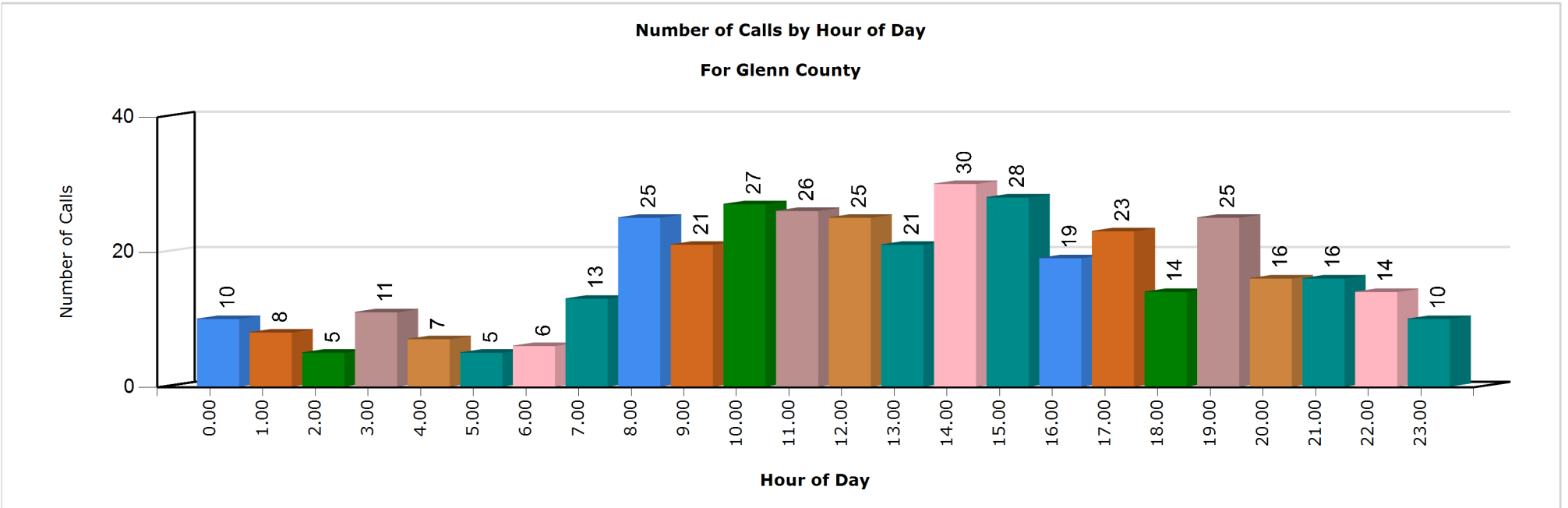

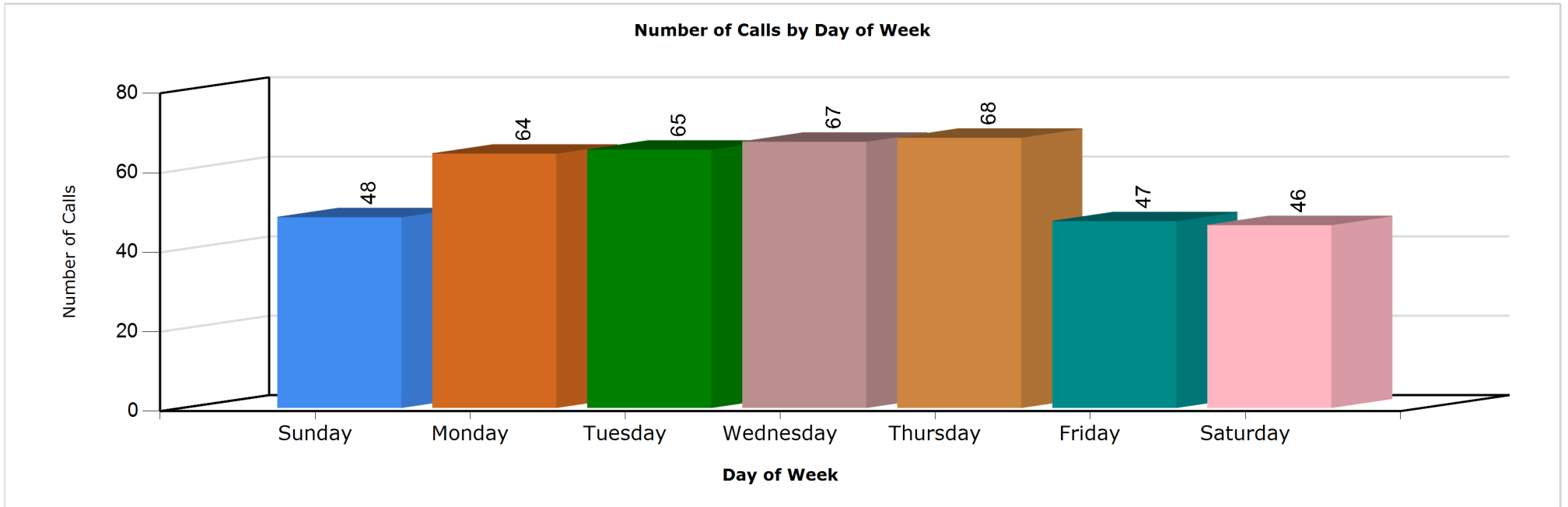


Hour of Day and Day of Week - CFS Report
