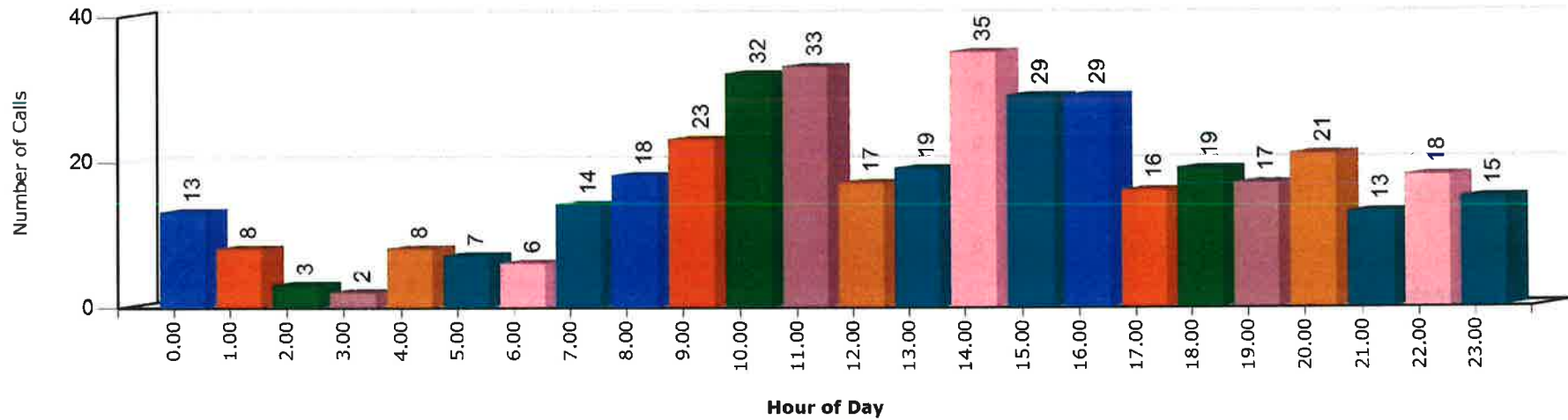

For Glenn County



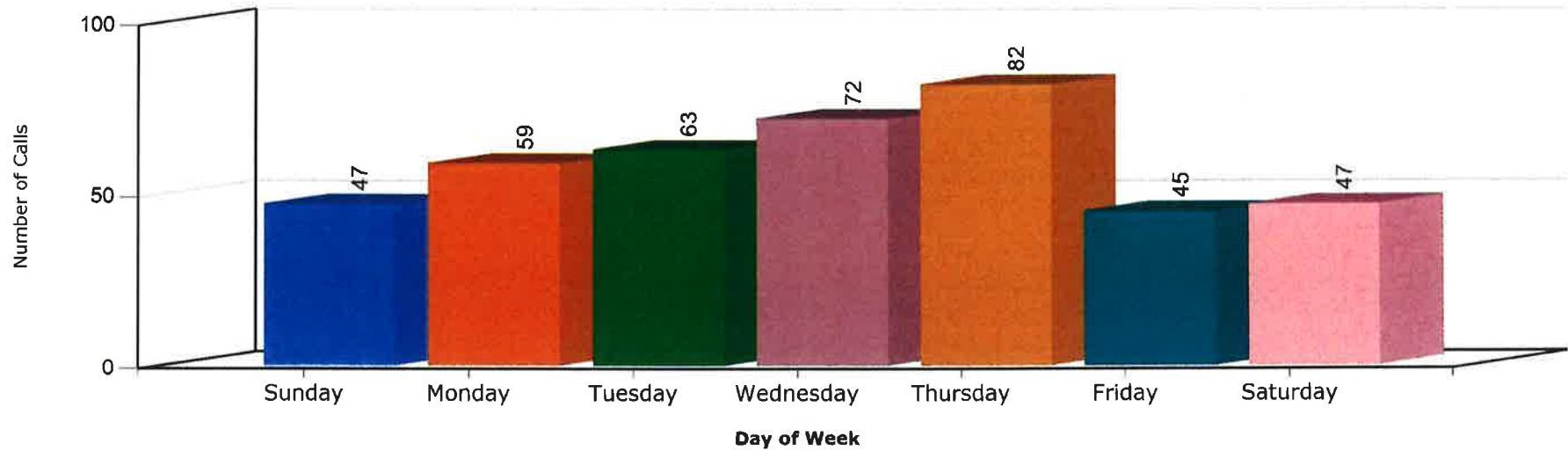
